⚠ This symbol is to alert you to important operating or servicing instructions that may appear in this user's manual. Always follow basic safety precautions when using this product to reduce the risk of injury, fire, or electric shock.

Safety information

- **Read and understand all instructions in the user's manual. Observe all markings on the product.**
- **Avoid using a telephone during a thunderstorm.** There may be a slight chance of electric shock from lightning.
- **Do not use a telephone in the vicinity of a gas leak.** If you suspect a gas leak, report it immediately, but use a telephone away from the area where gas is leaking. If this product is a cordless model, make sure the telephone base is also away from the area.
- **Do not use this product near water or when you are wet.** For example, do not use it in a wet basement or shower, nor next to a swimming pool, bathtub, kitchen sink, and laundry tub. Do not use liquids or aerosol sprays for cleaning. If the product comes in contact with any liquids, unplug any line or power cord immediately. Do not plug the product back in until it has dried thoroughly.
- **Install this product in a protected location where no one can trip over any line or power cords.** Protect cords from damage or abrasion.
- **If this product does not operate normally, see the Troubleshooting section.** If you cannot solve the problem, or if the product is damaged, refer to the **Limited warranty**. 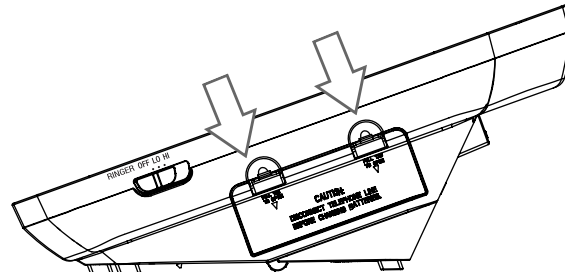

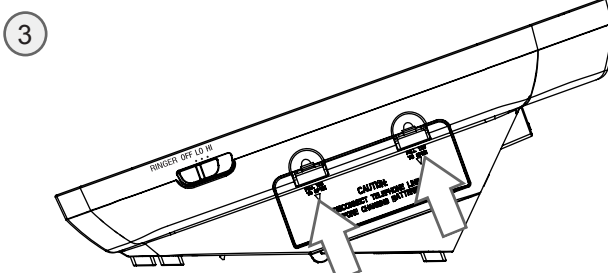
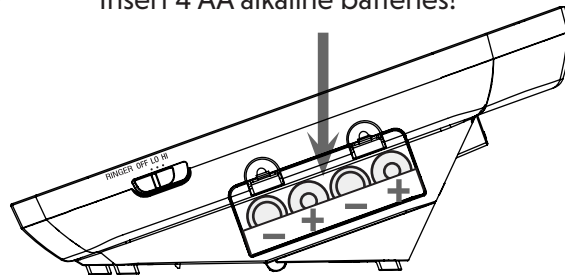
1 INSTALL BATTERY

This telephone requires four alkaline AA batteries (not included). When there is no battery installed or the power of the installed batteries is low, this telephone will work only to make or answer calls with the handset.

- 1 Press down and pull to open!



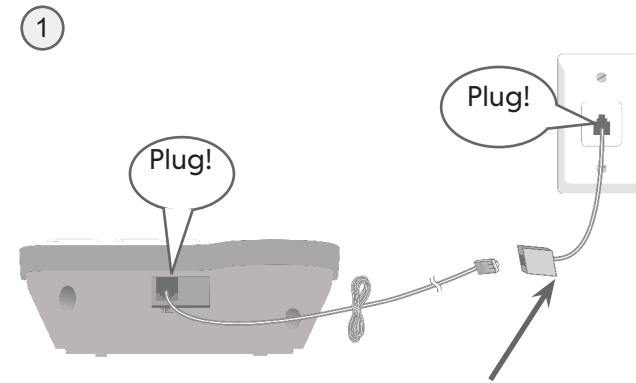
- 2 Insert 4 AA alkaline batteries!



Close and snap into place!

CAUTION: Always unplug the telephone line cord before installing new batteries.

2 INSTALL TELEPHONE BASE



If you have DSL high-speed Internet service, a DSL filter (not included) is required. The DSL filter must be plugged into the telephone wall jack.



3 SET DATE AND TIME

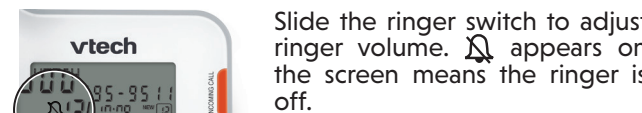
1. Press **MENU/SELECT** repeatedly until the screen displays:

DATE/TIME

1-01 12:00^{AM}

2. Use the dial pad keys (0-9) to change the blinking digits.
 - Press **▼** or **▲** to move to the previous or next digit.
 - Press **#** (pound key) to select between **AM** and **PM**.
3. Press **MENU/SELECT** to save the new setting and move to the next option.

4 SET RINGER VOLUME



(**RINGER OFF-LO-HI**) design

Slide the ringer switch to select your preferred ringer volume.

5 SET CONTRAST

Adjust the screen brightness to a comfortable level, from 1 (light) to 4 (dark).

1. Press **MENU/SELECT** repeatedly until the screen displays:
2. Press **▼** or **▲** until the screen displays the contrast level you prefer.
3. Press **MENU/SELECT** to save the setting.

6 SET HOME AREA CODE

A home area code must be programmed to use the display dial feature.

1. Press **MENU/SELECT** repeatedly until the screen displays:

HAC-___

2. Use the dial pad keys (0-9) to enter the home area code.
 - Press **▲** to move to the next digit.
 - Press **▼** to backspace.
 - Press **DELETE** to delete a digit.
3. Press **MENU/SELECT** to save the setting.

7 SET LOCAL AREA CODE

1. Press **MENU/SELECT** repeatedly until the screen displays:

LOCL AREA CODE

LAC-___

2. Use the dial pad keys (0-9) to enter the local area code.
 - Press **▲** to move to the next digit.
 - Press **▼** to backspace.
 - Press **DELETE** to delete a digit.
3. Press **MENU/SELECT** to save the setting.
4. Repeat steps 2-3 to set more local area codes.

8 SET DIRECTORY

This telephone has a directory where you can store up to 25 telephone numbers and names. Numbers can be up to 24 digits long and names can be up to 15 characters.

To add a directory entry:

1. Press **▲** → **▼** or **▲** → **STORE** flashes → **MENU/SELECT**.
2. Enter the telephone number → **MENU/SELECT**.
3. Enter the name → **MENU/SELECT**.

To review and dial a directory entry:

1. Press **▲**.
2. Press **▼** or **▲** until **REVIEW** flashes.
3. Press **MENU/SELECT** → **▼** or **▲** to scroll through the directory, then lift the handset or press **SPEAKER**.

To delete a directory entry:

1. Press **▲**.
2. Press **▼** or **▲** until **REVIEW** flashes.
3. Press **MENU/SELECT** → **▼** or **▲** to scroll through the directory → press **DELETE** → **MENU/SELECT**.

9 SPEED DIAL

There are 14 speed dial locations (seven upper and seven lower). To access an upper location, press a speed dial key. To access a lower location, press **LOWER**, then press a speed dial key.

To assign a speed dial entry:

1. Press a speed dial location, or press **LOWER**, then the desired speed dial location → press **MENU/SELECT**.
2. Enter the telephone number → press **MENU/SELECT**.

To dial a speed dial entry:

1. Lift the handset or press **▶SPEAKER**.
2. Press the desired speed dial location, or press **LOWER**, then the desired speed dial location.

To delete a speed dial entry:

Press the desired speed dial location, or press **LOWER**, then the desired speed dial location → Press **DELETE** → **MENU/SELECT**.

CALLER ID

- To review the call history:**
- Press ▼ to enter the call history.
 - Press ▼ or ▲ to scroll through the caller ID entries.
 - Press **CANCEL** to exit and return to idle mode.

- To dial a caller ID entry:**
- Press ▼ to enter the call history.
 - Press ▼ or ▲ to scroll through the caller ID entries.
 - Lift the handset or press **SPEAKER** to call.

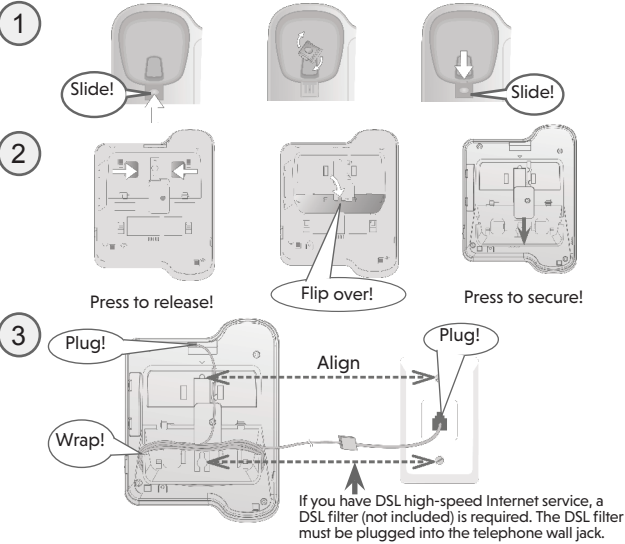
- To delete a caller ID entry:**
- Press ▼ to enter the call history.
 - Press ▼ or ▲ to scroll through the caller ID entries.→ press **DELETE** → **MENU/SELECT**.

- To delete all caller ID entries:**
- When the telephone is idle,press and hold **DELETE** → press **MENU/SELECT**.

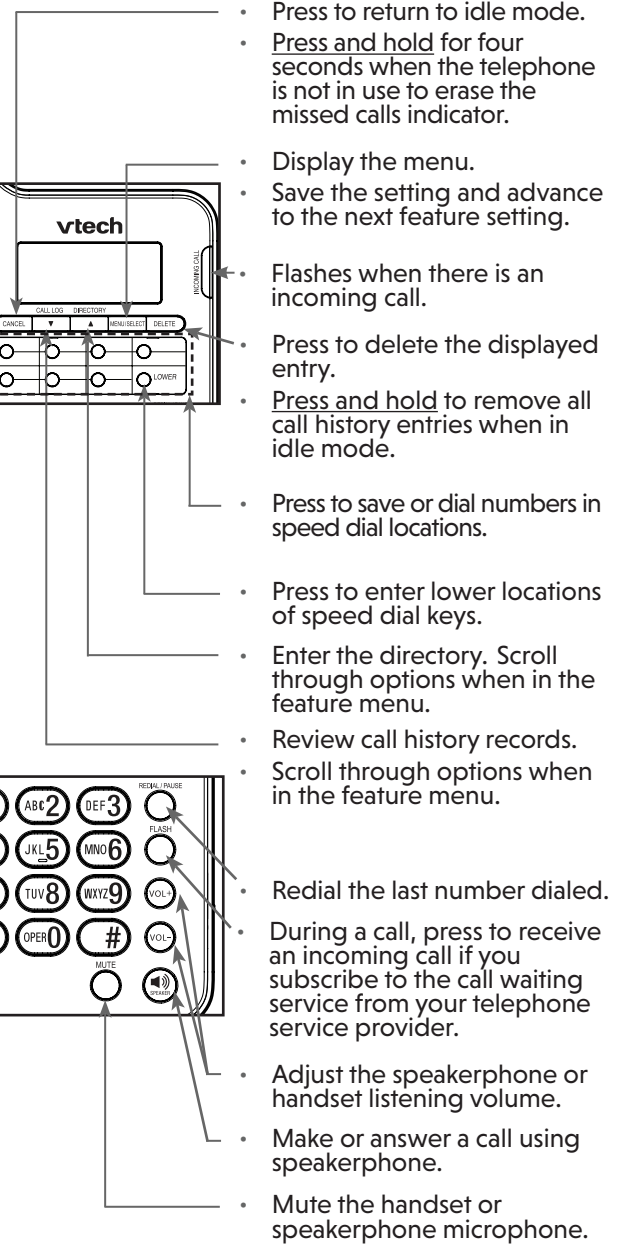
- Missed (new) call indicator**
- If you do not want to review the missed calls one by one, but still want to keep them in the caller ID log, you can press and hold **CANCEL** on the telephone for four seconds when the telephone is idle.

TELEPHONE OVERVIEW



- Press to return to idle mode.
- Press and hold for four seconds when the telephone is not in use to erase the missed calls indicator.
- Display the menu.
- Save the setting and advance to the next feature setting.
- Flashes when there is an incoming call.
- Press to delete the displayed entry.
- Press and hold to remove all call history entries when in idle mode.
- Press to save or dial numbers in speed dial locations.
- Press to enter lower locations of speed dial keys.
- Enter the directory. Scroll through options when in the feature menu.
- Review call history records.
- Scroll through options when in the feature menu.
- Redial the last number dialed.
- During a call, press to receive an incoming call if you subscribe to the call waiting service from your telephone service provider.
- Adjust the speakerphone or handset listening volume.
- Make or answer a call using speakerphone.
- Mute the handset or speakerphone microphone.

TROUBLESHOOTING

- If you have difficulty with your product, please try the following suggestions. For customer service, visit our website at www.vtechphones.com, or call **1 (800) 595-9511**. In Canada, visit phones.vtechcanada.com, or dial **1 (800) 267-7377**.
- No dial tone.**
- Make sure all plugs are connected properly. Inspect the telephone line cord connections at the wall jack and telephone. Also inspect the coiled handset cord connections at both ends.
 - Unplug the telephone and connect it to another wall jack. If it still does not work and other telephones in your home are working, the problem is with this telephone.
- Telephone does not ring.**
- Try setting the **RINGER** switch to + or HI.
 - If there are several other telephones on the same line, try disconnecting some of the other telephones. Having too many telephones connected can also create problems such as low ringer volume or impaired sound quality during calls.
- Difficulty storing numbers in memory.**
- Make sure you are pressing the correct sequence of keys for storing numbers.
 - If you are interrupted by a recorded announcement asking you to hang up or by a loud buzzing noise, hang up and store the number without lifting the handset.
- Screen is blank.**
- Make sure the batteries are correctly installed.
 - Replace batteries with new batteries.
- Caller ID isn't working.**
- Caller ID is a subscription service. You must subscribe to this service from your telephone service provider for this feature to work on your telephone.
 - If you subscribe to high-speed Internet service (DSL - digital subscriber line) through your telephone line, you must install a DSL filter between the telephone line cord and the telephone wall jack. The filter prevents noise and caller ID problems caused by DSL interference. Please contact your DSL service provider for more information about DSL filters.
 - Your caller must be calling from an area that supports caller ID.
 - Both your and your caller's telephone service providers must use equipment that is compatible with caller ID.
- No caller ID information while on a call.**
- Make sure your telephone service provider provides caller ID information while you are on a call. This is sometimes known as caller ID on call waiting or type 2 caller ID.
 - The telephone cannot display the caller ID information if another telephone on the same line is in use. Make sure all extensions are on hook.
- Screen incorrectly displays IN USE/NO LINE.**
- Make sure the telephone line cord is connected properly.

- I subscribe to a nontraditional telephone service that uses my computer to establish connections, and my telephone doesn't work.**
- Make sure your computer is powered on.
 - Make sure your Internet connection is working properly.
 - Make sure that the software is installed and running for your nontraditional telephone service.
 - Make sure to plug your USB telephone adapter into a dedicated USB port on your computer. Do not plug into a multiple port USB hub (USB splitter) that is not powered.
 - In a few rare instances, the USB port on your computer may not have enough power. In these instances, try using a USB hub with its own external power supply.
 - If you are using a firewall, it may prevent access to your nontraditional telephone service. Contact your service provider for more information.
- I've set my LCD language to Spanish or French and I don't know how to change it back to English.**
- When the telephone is idle, press **MENU/SELECT**, and then enter ***3645474#**. The LCD language is reset to English and the telephone returns to idle mode.
- Maintenance**
- Taking care of your telephone**
- Your telephone contains sophisticated electronic parts, so it must be treated with care.
- Avoid rough treatment.**
- Place the handset down gently. Save the original packing materials to protect your telephone if you ever need to ship it.
- Avoid water**
- Your telephone can be damaged if it gets wet. Do not handle it with wet hands. Do not install the telephone near a sink, bathtub or shower.
- Electrical storms**
- Electrical storms can sometimes cause power surges harmful to electronic equipment. For your own safety, take caution when using electric appliances during storms.
- Cleaning your telephone**
- Your telephone has a durable plastic casing that should retain its luster for many years. Clean it only with a soft cloth slightly dampened with water or a mild soap.
 - Do not use excess water or cleaning solvents of any kind.
- Remember that electrical appliances can cause serious injury if used when you are wet or standing in water. If the telephone base should fall into water, DO NOT RETRIEVE IT UNTIL YOU UNPLUG THE TELEPHONE LINE CORD FROM THE WALL. Then, pull the unit out by the unplugged cord.

FCC AND ACTA INFORMATION

- If this equipment was approved for connection to the telephone network prior to July 23, 2001, it complies with Part 68 of the Federal Communications Commission (FCC) rules. If the equipment was approved after that date, it complies with the Part 68 rules and with the Technical Requirements for Connection of Equipment to the Telephone Network adopted by the Administrative Council for Terminal Attachments (ACTA). We are required to provide you with the following information.
- Product identifier and REN information**

The label on the back or bottom of this equipment contains, among other things, an identifier indicating product approval and the Ringer Equivalence Number (REN). This information must be provided to your telephone service provider upon request. For equipment approved prior to July 23, 2001, the product identifier is preceded by the phrase "FCC Reg No." and the REN is listed separately. For equipment approved after that date, the product identifier is preceded by "US" and a colon (:), and the REN is encoded in the product identifier without a decimal point as the sixth and seventh characters following the colon. For example, the product identifier US:AAAEQ03TL23XYZ indicates the REN would be 0.3. The REN is used to determine how many devices you can connect to your telephone line and still have them ring when you are called. In most, but not all areas, the sum of all RENs should be five (5.0) or less. You might want to contact your telephone service provider for more information.
 - Connection and use with the nationwide telephone network**

The plug and jack used to connect this equipment to the premises wiring and the telephone network must comply with the applicable Part 68 rules and technical requirements adopted by ACTA. A compliant telephone cord and modular plug is provided with this product. It is designed to be connected to a compatible modular wall jack that is also compliant. An RJ11 jack should normally be used for connecting to a single line and an RJ14 jack for two lines, see installation instructions in the user's manual. This equipment may not be used with coin telephone lines or with party lines. If you have specially wired alarm dialing equipment connected to your telephone line, ensure the connection of this equipment does not disable your alarm equipment. If you have questions about what will disable the alarm equipment, consult your telephone service provider or qualified installer.
 - Replacement instructions**

If this equipment is malfunctioning, it must be unplugged from the modular wall jack until the problem has been corrected. Replacement to this telephone equipment can only be made by the manufacturer or its authorized agents. For replacement procedures, follow the instructions outlined under the limited warranty.
 - Rights of the telephone service provider**

If this equipment is causing harm to the telephone network, the telephone service provider may temporarily discontinue your telephone service. The telephone service provider is required to notify you before interrupting service. If advance notice is not practical, you will be notified as soon as possible. You will be given the opportunity to correct the problem and the telephone service provider is required to inform you of your right to file a complaint with the FCC. Your telephone service provider may make changes in its facilities, equipment, operation, or procedures that could affect the proper functioning of this product. The telephone service provider is required to notify you if such changes are planned.
 - Hearing aid compatibility**

If this product is equipped with a corded or cordless handset, it is hearing aid compatible.
 - Programming/testing of emergency numbers**

If this product has memory dialing locations, you may choose to store police, fire department and emergency medical service telephone numbers in these locations. If you do, please keep three things in mind:

 - We recommend that you also write the telephone number on the directory card (if applicable), so that you can still dial the emergency number manually if the memory dialing feature doesn't work.
 - This feature is provided only as a convenience, and the manufacturer assumes no responsibility for customer reliance upon the memory feature.
 - Testing the emergency telephone numbers you have stored is not recommended. However, if you do make a call to an emergency number:
 - You must remain on the line and briefly explain the reason for the call before hanging up.
 - Programming/testing of emergency numbers should be performed during off-peak hours, such as in the early morning or late evening, when the emergency services tend to be less busy.

PART 15 OF FCC RULES

- What does this limited warranty cover?**

The manufacturer of this Vtech branded product warrants to the holder of a valid proof of purchase ("CONSUMER" or "you") that the product and all accessories provided in the sales package ("PRODUCT") are free from defects in material and workmanship, pursuant to the following terms and conditions, when installed and used normally and in accordance with the PRODUCT operating instructions. This limited warranty extends only to the CONSUMER for products purchased and used in the United States of America and Canada.
 - What will be done if the PRODUCT is not free from defects in materials and workmanship during the limited warranty period ("materially defective PRODUCT")?**

During the limited warranty period, the manufacturer's authorized service representative will replace at the manufacturer's option, without charge, a materially defective PRODUCT. If the manufacturer chooses to replace the PRODUCT, they may replace it with a new or refurbished PRODUCT of the same or similar design. The manufacturer will retain defective parts, modules, or equipment. Replacement of the PRODUCT, at the manufacturer's option, is your exclusive remedy. The manufacturer will return replacement products to you in working condition. You should expect the replacement to take approximately 30 days.
 - How long is the limited warranty period?**

The limited warranty period for the PRODUCT extends for ONE (1) YEAR from the date of purchase. If the manufacturer replaces a materially defective PRODUCT under the terms of this limited warranty, this limited warranty also applies to replacement PRODUCT for a period of either (a) 90 days from the date the replacement PRODUCT is shipped to you or (b) the time remaining on the original one-year limited warranty; whichever is longer.
 - What is not covered by this limited warranty?**

This limited warranty does not cover:

 - PRODUCT that has been subjected to misuse, accident, shipping or other physical damage, improper installation, abnormal operation or handling, neglect, inundation, fire, water, or other liquid intrusion; or
 - PRODUCT that has been damaged due to repair, alteration, or modification by anyone other than an authorized service representative of the manufacturer; or
 - PRODUCT to the extent that the problem experienced is caused by signal conditions, network reliability or cable or antenna systems; or
 - PRODUCT to the extent that the problem is caused by use with non-Vtech accessories; or
 - PRODUCT whose warranty/quality stickers, PRODUCT serial number plates or electronic serial numbers have been removed, altered or rendered illegible; or
 - PRODUCT purchased, used, serviced, or shipped for repair from outside the United States of America or Canada, or used for

- commercial or institutional purposes (including but not limited to products used for rental purposes); or
 - PRODUCT returned without valid proof of purchase (see item 6); or
 - Charges for installation or setup, adjustment of customer controls, and installation or repair of systems outside the unit.
- How do you get warranty service?**

The manufacturer will return replaced PRODUCT under this limited warranty. Transportation, delivery or handling charges are prepaid. The manufacturer assumes no risk for damage or loss of the PRODUCT in transit. If the PRODUCT failure is not covered by this limited warranty, or proof of purchase does not meet the terms of this limited warranty, the manufacturer will notify you and will request that you authorize the cost of replacement prior to any further replacement activity. You must pay for the cost of replacement and return shipping costs for the products that are not covered by this limited warranty.
 - What must you return with the PRODUCT to get warranty service?**

You must:

 - Return the entire original package and contents including the PRODUCT to the service location along with a description of the malfunction or difficulty; and

State/Provincial Law rights: This warranty gives you specific legal rights, and you may also have other rights which vary from state to state or province to province.

Limitations: Implied warranties, including those of fitness for a particular purpose and merchantability (an unwritten warranty that the PRODUCT is fit for ordinary use) are limited to one year from date of purchase. Some states/provinces do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.
